ORDER:

In the Government Order first read above, orders have been issued for the establishment of one Early Intervention Centres in 10 districts for infants and young children with Hearing Impairment at an estimated cost of Rs.30.00 lakhs through Bala Vidyalaya High School for the deaf.

2. In the Government Order second read above, orders have been issued to extend scheme of the Early Intervention Centre for infants and young children with Hearing Impairment in remaining 21 districts.

3. In the Government Order third read above, orders have been issued for the continuance of the scheme of Early Intervention Centres for infants and young children with Hearing Impairment in 31 districts during the year 2010-11, with total cost of Rs.85,29,500/-.

4. The State Commissioner for the Differently Abled in the letter fourth read above has stated that the Tiruppur district has been bifurcated from Coimbatore district during the year 2008-09. At present there are 20 children with hearing impairment in the age group of 0-3 years in Tiruppur district and there is no Early Intervention Centre for Hearing Impaired in Tiruppur district. Since these children are very young it is difficult for the parents to take them to Early Intervention Centre functioning in the nearby district namely, Coimbatore and Erode. Hence, it is necessary to establish a Early Intervention Centres for Infants and Young children with Hearing Impairment in Tiruppur District. 5. The Government after careful consideration has decided to accept the proposal of the State Commissioner for the Differently Abled and issue following orders:

- i. Permission to establish the Early Intervention Centre for infant and young children withHearing Impaired at Tiruppur from 01.11.2011 through reputed NGO.
- ii. Sanction to incur an expenditure of Rs.1,59,500/- (Rupees one lakh fifty nine thousand and five hundred only) as detailed in the annexure to this order.
- iii. Permission to the State Commissioner for the Differently Abled to draw and disburse the amount sanctioned as above to concerned NGOs through District Differently Abled Welfare Officers (DDAWOs) as an advance.
- iv. Permission to decide on selection and removal of implementing NGOs.

6) The expenditure sanctioned at para 5(ii) above shall be debited under the following Head of Account: -
