ORDER:

In the Government Order first read above, orders were issued sanctioning a sum of Rs.19.00 lakhs towards the Scheme of Readers Allowance to the Visually Handicapped differently abled students for the year 2009-10.

- 2. The State Commissioner for the Differently Abled has sent the proposal for the continuance of the scheme for grant of Readers Allowance to visually impaired differently abled students studying in schools and colleges for the year 2010-11 and requested to sanction a sum of Rs.19.00 lakhs towards the above scheme.
- 3. After careful examination, the Government accept the proposal of the State Commissioner for the Differently Abled and accordingly sanction a sum of Rs.19.00 lakhs (Rupees Nineteen lakhs only) for the continuance of the scheme of Readers Allowance to the visually Impaired differently abled students studying in school , and colleges for the year 2010-11.
- 4. The expenditure sanctioned in para 3 above shall be debited under the following head of account:

"2235-Social Security and Welfare -02-Social Welfare-101 Welfare of Differently Abled -I Non Plan –BB Scholarships to the Differently abled Students -12 scholarships and Stipends-09 Others.
