## Order:

In the Government Order first read above orders have been issued for sanction of Rs.261.00 lakhs for continuance of the scheme of scholarship to the differently abled students for the year 2009-10. In the Government Order second read above, an additional amount of Rs. 60.09 lakhs was also allotted under the scheme of scholarship to the differently abled students for the year 2009-10.

- 2) The State Commissioner for the Differently Abled has stated that the funds have been distributed to the Districts according to requirement and fully utilized. He has also furnished utilization certificate. During the current financial year a sum of Rs.280.00 lakhs has been provided for Scholarship to differently abled Students and Readers Allowances to visually impaired Students. Out of Rs.280.00 lakhs Rs.261.00 lakhs may be utilized towards the scheme of scholarship to differently abled students studying in Schools and Colleges. The State Commissioner for the Differently Abled has therefore requested the Government to sanction an amount of Rs.261.00 lakhs towards payment of scholarship amount to the differently abled students.
- 3) After careful examination, the Government, accept the proposal of the State Commissioner for the Differently Abled and accordingly accord sanction for an amount of Rs.261.00 lakhs (Rupees two hundred and sixty one lakhs only) for continuing the scheme of scholarship to the Differently Abled students for the year 2010-11.

4) The expenditure sanctioned in para 3 above shall be debited under the following head of account:-

"2235 – Social Security and Welfare – 02-Social Welfare – 101 – Welfare of Differently abled - I – Non Plan – BB – Scholarships to the Differently abled students – 12 Scholarships and stipends – 09 others. (D.P.Code .2235-02-101-BB-1290).
