From the State Commissioner for the Differently Abled, letter No.3292/SS2/09, dated 03.08.2009 and 08.02.2010.

ORDER:-

In the letter read above, the State Commissioner for the Differently Abled has reported that the Department for the Differently Abled is giving special training for teaching the Visually Impaired, Hearing Impaired and Mentally Retarded Persons. The special training in teaching the Visually Impaired Persons is being given through Government Higher Secondary School for the Blind, Poonamallee, the special training to teach the Hearing Impaired Persons is being given through Little Flower Convent Higher Secondary School for the Deaf, Chennai -6 and the special training for teaching the Mentally retarded is being given through Balavihar, Chennai -10.

- 2. The State Commissioner for the Differently Abled Persons has also stated that the Secondary Teacher Training Course is also being given for the orthopaedically challenged persons at Government Higher Secondary School for the blind, Poonamallee. For this training programme also wide publicity is being given in the leading dailies and therefore requested to sanction funds towards advertisement charges for inviting applications for the above mentioned special training courses to the tune of Rs.73,661/- and for Rs.98,214/- for Secondary Grade Teachers Training Course.
- 3. In this regard, the State Commissioner for the Differently Abled has requested the Government for sanction of Rs.1, 71,875/- and he has reported that an allotment of Rs.70, 000/- is already available in the relevant Head of Account and hence an additional allotment of Rs.1, 01,875/- may be made so as to enable to clear the pending bills, during the current financial year.
- 4. The Government have examined in detail the proposal of the State Commissioner for the Differently Abled. As the advertisement was released by State Commissioner for the Differently Abled through M/s Sasi Advertising consultants, Chennai which is in the approved list maintained by the DIPR, it

has been decided to accept the same. Accordingly, sanction is accorded by the Government for an amount of Rs.1,71,875/- (Rupees One Lakh seventy one thousand eight hundred and seventy five only) towards advertisement charges.

5. The expenditure sanctioned in para 4 may be debited under the following head of account.:-

- 6. The additional expenditure of Rs.1,01,875/- over and above the provisions made in BE 2010–11 will be provided in the RE/FMA 2010-11. Pending provision of funds in RE/FMA 2010-11, the State Commissioner for the Differently Abled Persons is authorised to incur the expenditure. The State Commissioner for the Differently Abled is requested to include the above expenditure while sending budget proposals for RE/FMA 2010 11 at the appropriate time without fail.
