ORDER:

The Government after careful consideration, accept the proposal of State Commissioner for the Differently Abled and direct that the following members will constitute the Selection Committee at State level to select the suitable candidates for receiving State Awards under various categories which will be given during Independence Day and International Day of the Differently Abled by Her Excellency the President of India.
