## **ORDER:**

In the letter first read above the State Commissioner for the Differently Abled has requested permission to continue the scheme of Regional State Resource cum Training Centre at Trichy during the year 2014-2015 and requested to sanction a sum of Rs.9,81,300/- for the same. Further, the State Commissioner for the Differently Abled has requested permission to decide on the selection and removal of the implementing Non Governmental Organisations and also to draw and disburse the amount as an advance to the implementing Non Governmental Organisation through District Differently Abled Welfare Officer, Tiruchirappalli. The Government after careful examination, has decided to accept the proposal of the State Commissioner for the Differently Abled and accord permission for continuance of Regional State Resource cum Training Centre at Trichy for the year 2014-15 and to accord sanction a sum of Rs.5,16,658/- (Rupees Five lakhs sixteen thousand six hundred and fifty eight only) for the same in the Government Order second read above.

2. In the letters third read above, the State Commissioner for the Differently Abled has sent proposals for continuance of the scheme for the year 2014-2015 and requested to sanction the balance amount of Rs.4,64,642/-.

3. After careful examination, it has been decided to accept the proposal of the State Commissioner for the Differently Abled accord sanction of balance amount of Rs.4,64,642/- (Rupees Four lakhs sixty four thousand six hundred and forty two only) towards the scheme continuance of Regional State Resource cum Training Centre at Trichy for the year 2014-2015.

4. The amount sanction in para 3 above shall be debited to the following Head of Account

“2235-Social Security and Welfare 02-Social Welfare-101- Welfare of the Differently Abled Persons-I Non Plan-DE- State Resource cum Training Centre - 09-Grants-in-Aid-03-Grants for specific scheme.”

5. Further, the State Commissioner for the Differently Abled is permitted to draw and disburse the amount sanctioned in para 3 above to the implementing Non Governmental Organisation through District Differently Abled Welfare Officer, Tiruchirappalli.
