### **ORDER:**

In the Government order first read above, orders were issued to delegate powers to the State Commissioner for the Differently Abled to implement the following 4 Welfare Schemes of Differently Abled Persons with the condition that the expenditure should be incurred only within the Budget provision of the respective Head of Account:-

- i. Maintenance Allowance to Mentally Retarded persons,
- ii. Maintenance Allowance to Severely Affected persons,
- iii. Maintenance Allowance to Persons affected with Muscular Dystrophy; and
- iv. Maintenance Allowance to Leprosy affected persons.

Further, the Government has permitted the State Commissioner for the Differently Abled to send necessary proposal to Government for sanction of funds if required for the additional beneficiaries identified subsequently in the month of September and February.

- 2. In the Government Orders second read above, orders were issued to enhance the maintenance allowance for persons affected with Muscular Dystrophy from Rs.1000/- to Rs.1500/- per month from 01.04.14 and accorded sanction for the total sum of Rs.1,29,78,000/- to provide maintenance allowance to 1883 number of beneficiaries for 12 months.
- 3. In the proceedings third read above, the amount of Rs.1,29,78,000/sanctioned in Government Orders second read above, had been disbursed to the District Differently Abled Welfare Officers of all Districts. The State Commissioner for the Differently Abled has allotted amount of Rs.5,82,000/- to Coimbatore District and the details of amount sanctioned to District Differently Abled Welfare Officer, Coimbatore is as given below:-

a)	34-Existing beneficiaries x Rs.500/- x 12 months	Rs.2,04,000/-
b)	21- Additional beneficiaries x Rs.1500/- x 12 months	Rs.3,78,000/-
	Total	Rs.5,82,000/-

- 4. In the letters fourth read above, the State Commissioner for the Differently Abled has stated that out of the total amount of Rs.5,82,000/- sanctioned for providing maintenance allowance to persons affected with Muscular Dystrophy in Coimbatore District, an amount of Rs.3,78,000/- was claimed for providing maintenance allowance to 21 additional beneficiaries at the rate of Rs.1500/- for 12 months. But the amount of Rs.2,04,000/- sanctioned for 34 existing beneficiaries at Rs.500/- per month was not claimed due to negligence of the District Differently Abled Welfare Officer, Coimbatore and hence the amount of Rs.2,04,000/- was surrendered to Government account.
- 5. Now, the State Commissioner for the Differently Abled has requested the Government to permit to incur a sum of Rs.2,04,000/- from the balance amount of Rs.11,06,000/- available in the Budget Estimate 2015-16 towards payment of arrear amount of Rs.500/- to 34 beneficiaries in Coimbatore district for 12 months for the year 2014-15.
- 6. The Government after careful examination has decided to accept the proposal State Commissioner for the Differently Abled permitted to incur a sum of Rs.2,04,000/from the balance amount of Rs.11,06,000/- available amount in the Budget Estimate 2015-16 towards payment of arrear amount of Rs.500/- to 34 existing beneficiaries in Coimbatore District for 12 months ie for 2014-2015.

7. The expenditure sanctioned at para 4 above shall be debited under the following Head of Account:-

"2235- Social Security and Welfare-02. Social Welfare-101- Welfare of Differently Abled –I- Non Plan- CM- Maintenance Grants to the Persons With Muscular Dystrophy Disease 09. Grants –in-Aid 03. Grants for Specific Schemes".
