#### ORDER:

In the Government Order first read above, orders were issued to continue the scheme of Regional State Resource cum Training Centre at Trichy for the year 2015-16 and sanctioned a sum of Rs.9,81,300/- for the scheme.

In the letter second read above, the State Commissioner for the Differently Abled has requested the Government for continuance of the scheme of Regional State Resource cum Training Centre at Trichy during the year 2016-17 and to sanction a sum of Rs.9,81,300/- and also requested to permit the State Commissioner for the Differently Abled to draw and disburse the amount to the implementing Non Governmental Organisation through District Differently Abled Welfare Officer, Tiruchirapalli.

3. The Government after careful examination has decided to accept the proposal of the State Commissioner for the Differently Abled and accord permission for continuance of the State Resource cum Training Centre at Trichy for the year 2016-17 and to sanction a sum of Rs.9,81,300/- (Rupees Nine lakhs eighty one thousand and three hundred only) as detailed below:-
