Welfare of Differently Abled Persons – "Early Intervention Centres for the Visually Impaired Children"-Scheme continuance for the year 2015-2016-Sanction of expenditure of Rs. 28,26,000/- Orders- Issued.

ORDER:

In the Government Order first read above, orders were issued for continuance of the scheme of "Early Intervention Centre for children with visual impairment" in 11 districts for the year 2014-15 and sanction was accorded for a sum of Rs.34,54,000/-.

2. In the letter second read above, the State Commissioner for the Differently Abled has stated that the Virudhunagar centre have been closed from 1.4.2014 and the Tirunelveli centre did not function during the year 2014-2015 and 2015-16. Therefore, continuance of the scheme of 'Early Intervention Centre for the Visually Impaired' children has now proposed for 9 districts alone namely- Trichy, Coimbatore, Cuddalore, Chennai, Salem, Vellore, Tiruvannamalai, Krishnagiri, and Nagapattinam for the year 2015-16 and requested to accord sanction for a total amount of Rs.28,26,000/- .

3. After careful examination of the proposal of the State Commissioner for the Differently Abled, the Government permit the State Commissioner for the Differently Abled to continue the "Early Intervention Centre for the Visually Impaired children" in 9 districts alone during 2015-2016 as proposed and sanction is accorded for a total amount of Rs.28,26,000/- (Rupees Twenty eight lakhs and twenty six thousand only) for the year 2015-16 as detailed in the Annexure to this order.

4. Further, the State Commissioner for the Differently Abled is permitted to decide on the selection and removal of the implementation of Non Governmental Organisations with

the concurrence of Government and also the State Commissioner for the Differently Abled is permitted to draw the entire amount as an advance and to disburse the amount allotted for training, Honorarium to Computer Instructor, Early Intervention Centres and assessment clinics in advance to Non Governmental Organisations through the District Differently Abled Welfare Officers.

5. The amount sanctioned in para 3 above shall be debited under the following head of account:-

"2235- Social Security and Welfare 02- Social Welfare 101- Welfare of Differently Abled Persons- Twelfth Five Year Plan –II-State Plan- MS- Setting up of Early Intervention Centres for the Visually handicapped children below 6 years -09-Grants- in-aid-03- Grants for Specific Schemes.
