ORDER:

In Government Order first read above, orders were issued for continuance of the scheme of "Early Intervention Centre for children with Autism" at State Resource cum Training Centre at Chennai for the year 2013-14 and sanction was accord for a sum of Rs.2,82,000/-.

- 2. In the letter second read above, the State Commissioner for the Differently Abled has sent, a proposal for the continuance of the "Early Intervention Centre for Autism" at the State Resource-Cum-Training Centre for the differently abled for the year 2014-15 at a cost of Rs.2,82,000/-
- 3 The Government have examined the proposal of the State Commissioner for the Differently Abled and issue the following orders:
 - i. The State Commissioner for the Differently Abled is permitted to continue to run "Early Intervention Centre for Autism" at the State Resource-Cum-Training Centre for the Differently Abled, K.K. Nagar, Chennai for the year 2014-15.
 - ii. Financial sanction is accorded for incurring an expenditure of Rs.2,82,000/(Rupees Two lakhs and eighty two thousand only) to continue to implement the
 "Early Intervention Centre for Autism" scheme for the year 2014-15 as detailed
 below:-

- iii. The State Commissioner for the Differently Abled is permitted to draw the entire amount as an advance and to disburse the amount as an advance to the implementing Non Governmental Organisation.
- iv. The State Commissioner for the Differently Abled is permitted to decide on the selection and removal of the implementing Non Governmental Organisation in consultation with the Government.
- 4. The expenditure sanctioned in para 3 (ii) above shall be debited under the following head of account:-

"2235 – Social Security and Welfare-02- Social Welfare-101- Welfare of Differently Abled Persons I- Non Plan –DE- State Resource cum Training Centre 09. Grants in Aid- 03 Grants for Specific Schemes" (D.P. C.2235-02-101- DE- 0935)
