### ORDER:

In the Government Order first read above, adhoc rules were framed to the temporary posts of Administrative Officer, Government Rehabilitation Homes and Administrator, Government Care Camp, Melpakkam in Social Welfare and Nutritious Meal Programme Department.

- 2. In the Government Order second read above, Department for Welfare of Differently Abled Pesons was newly created by bifurcating from Social Welfare and Nutritious Meal Programme Department in Secretariat. In the Government Order third read above, orders were issued by transferring the cadre controlling power of all the personnel working under the control of State Commissioner for the Differently Abled from the Director of Social Welfare to the State Commissioner for the Differently Abled.
- 3. In the Government Order 5<sup>th</sup> read above, orders were issued by amending the Tamil Nadu Business Rules, interalia, the subject of Government Rehabilitation Homes and Government Care Camp, Melpakkam has been omitted from the heading of Social Welfare and Nutritious Meal Programme Department and inserted under the heading of "Welfare of Differently Abled Persons Department".

In the letter 4<sup>th</sup> read above, the Principal Secretary / State Commissioner for the Differently Abled has sent proposals for issue of an amendment to the adhoc rules for the post of Administrative Officer in Government Rehabilitation Homes and Administrator, Government Care Camp Melpakkam, so as to make provisions to appoint senior most Ministerial Superintendent of Welfare of Differently Abled Persons Department to the above posts.
- 5. The following Amendment will be published in the <u>Tamil Nadu Government</u> Gazette:-

## **NOTIFICATION.**

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Rules published with Social Welfare and Nutritious Meal Programme Department Notification No.SRO B-98/2003 published at page 126 of Part III-Section 1 (b) of the Tamil Nadu Government Gazette dated the 3<sup>rd</sup> December 2003.

2. The amendments hereby made shall be deemed to have come into force on and from the 12<sup>th</sup> July 2012.

## **AMENDMENTS.**

In the said Rules,-

- (1) in rule 1, for the expression "Social Welfare Department", the expression "Welfare of Differently Abled Persons Department" shall be substituted;
- (2) in rule 3, for the expression "Department of Social Welfare", the expression "Welfare of Differently Abled Persons Department" shall be substituted.
