ORDER:

In the Government Order 1st read above, orders were issued permitting the State Commissioner for the Differently Abled to set up an Information Centre for the Differently Abled Persons in the Office of the State Commissioner for the Differently Abled, and accord sanction of amount to the tune of Rs.8,47,000/- (Non Recurring Expenditure Rs.3,26,200/- Recurring Expenditure Rs.5,20,800/-) and also permitted to draw the entire amount as an advance under contingencies fund in the Government Letter second read above.

- 2. In the letter third read above, the State Commissioner for Differently Abled, has requested to permit him to continue to run the Information Centre to incur telephone charges based on the funds allocated in the Budget Estimate 2015-16 to avoid the disconnection of the phone lines and also to accord sanction for a sum of Rs.3,47,200/- as advance.
- 3. The Government, after careful examination, have decided to accept the request of the State Commissioner for Differently Abled and accord sanction for a sum of Rs.3,47,200/- for continuance of Information Centre for the differently abled persons from 01.08.2015 to 31.03.2016 for the total period of 8 months for the year 2015-2016 and permit him to incur the above expenditure.
