## ORDER:

In Government Order first read above, Government has sanctioned a sum of Rs.2,68,000/- towards Early Intervention Centre for Hearing Impaired run by the Little Flower Convent Higher Secondary School for the Deaf Chennai for the year 2014-15.

- 2. Now, the State Commissioner for the Differently Abled has submitted proposal for sanction of a sum of Rs.2,68,000/- for the Early Intervention Centre for Hearing Impairment facility in the Little Flower Convent for the Deaf for the year 2015-16.
- 3. The Government have examined the proposals of the State Commissioner for the Differently Abled carefully and to accord sanction a sum of Rs.2,68,000/-(Rupees Two lakhs and sixty eight thousand only) as grant to Little Flower Convent for the Deaf, Chennai under the scheme of Early Intervention Centre for Hearing Impaired for the year 2015-16, as detailed below:-
