ORDER:

In the letter read above, the State Commissioner for the Differently Abled has submitted a proposal and requested to issue 'No Objection Certificate' to Paul Institute of Special Teacher Training, Terre des homes Core Trust, Perumbakkam Road, Tiruvannamalai and that Institute has submitted an application seeking "No Objection Certificate" for starting "B.Ed., in Mental Retardation Special Education" course for the academic year 2016-17, so as to get approval from Rehabilitation Council of India for starting and conducting the above said course.

2. The State Commissioner for the Differently Abled has stated that the District Differently Abled Welfare Officer, Tiruvannamalai District has inspected the above institution on 06.08.2015 and submitted the Inspection Report along with the Questionnaire prescribed by Rehabilitation Council of India to ascertain the eligibility of the Institution to be given 'No Objection Certificate' for Rehabilitation Council of India courses. He has mentioned in his Inspection Report that the Institution is already running D.Ed., Special Education Mentally Retarded approved by Rehabilitation Council of India, Delhi from the year 2012. The District Differently Abled Welfare Officer, Tiruvannamalai District has mentioned that the Institution possesses good infrastructure facilities. The trust has good reputation in Tiruvannamalai District and has been implementing various child welfare projects. He has also mentioned that the Trust is implementing 3 early intervention centres for mentally retarded children in Tiruvannamalai District. Further, he has also furnished the Inspection Report of the District Differently Abled Welfare Officer along with the questionnaire. The institution has also submitted the copy of Fixed Deposit Receipt for the amount of Rs.3,00,000/-.
