ORDER:

In the Government Order first read above, under part-II scheme 2012-13, Government have permitted the Principal Secretary/State Commissioner for the Differently Abled to establish "Regional State Resource cum Training Centre" at Trichy through Non Governmental Organisations and sanctioned a sum of Rs.60.51 lakhs.

- 2. In the Government Order second read above, orders were issued to continue the scheme of Regional State Resource cum Training Centre at Trichy for the year 2013-14 and sanctioned a sum of Rs.9,81,300/- for the scheme.
- 3. In the Government Order third read above, orders were issued to continue the scheme of Regional State Resource cum Training Centre at Trichy for the year 2014-15 and sanctioned a part of amount (i.e) a sum of Rs.5,16,658/- for the scheme.
- 4. In the letter fourth read above, the State Commissioner for the Differently Abled has requested the Government for continuance of the scheme of Regional State Resource cum Training Centre at Trichy during the year 2015-16 and to sanction a sum of Rs.9,81,300/- and also requested to permit the State Commissioner for the Differently Abled to draw and disburse the amount to the implementing Non Governmental Organisation through District Differently Abled Welfare Officer, Tiruchirapalli.

5. The Government after careful examination has decided to accept the proposal of the State Commissioner for the Differently Abled and accord permission for continuance of the State Resource cum Training Centre at Trichy for the year 2015-16 and to sanction a sum of Rs.9,81,300/- (Rupees Nine lakhs eighty one thousand and three hundred only) as detailed below:-

The State Commissioner for the Differently Abled is permitted to decide on the selection and removal of the implementing Non Governmental Organisation and also to draw and disburse the amount to the implementing Non Governmental Organisation through District Differently Abled Welfare Officer, Trichy.

6. The amount sanctioned in para 5 above shall be debited to the following head of Account:-
