ORDER:

In the Government Order first read above, under part-II scheme 2012-13, Government have permitted the Principal Secretary/State Commissioner for the Differently Abled to establish "Regional State Resource cum Training Centre" at Trichy through Non Governmental Organisations and sanctioned a sum of Rs.60.51 lakhs.

- 2. In the letter second read above, the State Commissioner for the Differently Abled has requested the Government for continuance of the scheme of Regional State Resource cum Training Centre at Trichy during the year 2013-14 and to sanction a sum of Rs.9,81,300/-. Also permission sought for, to draw and disburse the amount to the implementing Non Governmental Organisation through District Differently Abled Welfare Officer, Tiruchirapalli.
- 3. The Government after careful examination has decided to accept the proposal of the Principal Secretary/ State Commissioner for the Differently Abled and accord permission for continuance of the State Resource cum Training Centre at Trichy for the year 2013-14 and to sanction a sum of Rs.9,81,300/- (Rupees Nine lakhs eighty one thousand and three hundred only) as detailed below:-
