ORDER:

The proposal of State Commissioner for the Differently Abled under the Part-II Schemes for the year 2014-15 towards establishment of Model Rehabilitation Centre for Children affected with Duchnne Muscular Dystrophy by Molecular Diagnostics, Counseling Care and Research Centre, Coimbatore are as follows:-

Duchenne Muscular Dystrophy (DMD) is the most common lethal genetic disorder diagnosed in childhood. It is an X-linked recessive inherited disorder, characterized by rapid progression of muscle weakness and wasting that occurs early in life, which affects approximately **1 in every 3,500 live male births**. In general, only males are afflicted, though females can be carriers. However, it occurs across all races and cultures. Two types of Muscular Dystrophy diseases are identified. First type is Duchenne Muscular Dystrophy. In this type the affected young men will be live into their early 20-25. Another one is Becker type Muscular Dystrophy. In this type the Human heart and lungs system will be affected in their age of 40-45.

2. The Muscular Dystrophy Diseases are identified by Genetic tastings. The MPCR and MLPA testing are mostly used to identify these Diseases. The affected children will be tested by the above Genetic Method. In the above stage, the Government will be setup a Model Rehabilitation Center for children affected with Duchenne Muscular Dystrophy by Molecular Diagnostics, Counseling Care & Research Centre, (MDCRC) Coimbatore. Further, the State Commissioner for the Differently Abled has requested the Government to sanction an amount of Rs.25,00,000/- for implementation the above scheme.

- 3. The Government have examined the proposal of the State Commissioner for the Differently Abled and issue the following orders:
 - i. Financial sanction is accorded for a sum of Rs.25,00,000/- (Rupees Twenty five lakhs only) as non-recurring expenditure as shown below, for establishment of a Model Rehabilitation Centre for children affected with Duchnne Muscular Dystrophy by Molecular Diagnostics, Counseling Care & Research Centre, (MDCRC) Coimbatore:-
