## **ORDER:**

In the letter read above ,the Principal Secretary / State Commissioner for the Differently Abled has stated that the Managing Trustee, Diya Trust of India, Tirunelveli District, has sent a proposal seeking grant for the Early Intervention Centre for children with Autism for the year 2013-14 as recommended by the District Differently Abled Welfare Officer, Tirunelveli. The Managing Trustee of Diya Trust of India , Tirunelveli District, has informed that the Institution has established the Early Intervention Centre for Autism in 2010 and now, there are 20 children and three Special Educators working in the centre. The Managing Trustee has requested for a grant of Rs.3,09,400/- from the State Government for the year 2013-14. However, this budget has been restricted by the Principal Secretary/State Commissioner for the Differently Abled to the tune of Rs.2,82,000/- based on the budget approved and sanctioned to Early Intervention Centre for Autism at the State Resource cum Training Centre , Chennai.

- 2. Further, the Principal Secretary / State Commissioner for the Differently Abled has requested the Government to examine and sanction of the grant to the institution.
- 3. The Government have examined the proposal of the Principal Secretary /State Commissioner for the Differently Abled and issue the following orders:-
  - The State Commissioner for the Differently Abled is permitted to continue to run the Early Intervention Centre for children with Autism at Diya Trust of India Tirunelveli District for the year 2013-14.
  - ii. Sanction is accorded for incurring an expenditure of Rs.47,000/- (Rupees Forty seven thousand only) detailed below for 2 months in the year 2013-14.

- 5. The State Commissioner for the Differently Abled is the Estimating, Reconciling and controlling authority for the above New Head of Account.
- 6. The Treasury Officers/Pay and Accounts Officer concerned are requested to open the above new head of account in account.
- 7. Necessary provision of Funds Rs.47,000/- will be provided in FMA 2013-14. Pending provision of funds in FMA 2013-14, the Principal Secretary / State Commissioner for the Differently Abled is authorized to draw and incur the expenditure sanctioned in para 3(ii) above. The State Commissioner for the Disabled is also requested to include this expenditure of Rs.47,000/- in the FMA for 2013-14, while sending a proposal to Government in Finance Department without fail.
