## **ORDER:**

In the Government order first read above orders were issued to accord , a sum of Rs.46,64,109/- was sanctioned for providing of Noon Meal and Weaning Food to the children with disabilities below 5 years in the 87 Early Intervention Centres for the year 2013-14 under the control of State Commissioner for the Differently Abled.

2. In the references second read above, the State Commissioner for the Differently Abled has stated that the existing numbers of Early Intervention Centres are 80 and requested to permit him to continue the scheme during the year 2015-2016 and to sanction a sum of Rs.4,00,000/- towards transport charges and to draw and disburse the amount as an advance to the implementing Non Governmental Organisations of Early Intervention Centres through District Differently Abled Welfare Officers. Further he has requested to Government to permit the State Commissioner for the Differently Abled to continue the scheme of providing Noon Meal and Weaning Food to children with Disabilities in the Early Intervention Centres during the year 2015-2016 and also requested to sanction a sum of Rs.4,00,000/-.

3. The Government after careful examination of the proposal of the State Commissioner for the Differently Abled and accord sanction for a sum of Rs.4,00,000/- (Rupees Four lakhs only) towards transport charges for providing of Noon Meal and

Weaning food to the children with disabilities in the 80 Early Intervention Centres functioning under the control of State Commissioner for the Differently Abled for the year 2015-16.

4. The amount sanctioned in para 3 shall be debited under the following head of accounts:-

“2235-Social Security and Welfare-02- Social Welfare-101-Welfare of Differently Abled Persons- Schemes in the Twelfth Five Year Plan-II State Plan- MW Assistance to the Non Governmental Organisations for Early Intervention Centre for bringing the Food from Anganwadi Centre to Early Intervention Centre.”-73-Transport

5. The amount sanctioned in para 3 above the State Commissioner for the Differently Abled to permit draw and disburse the amount as an advance to the implementing Non Governmental Organisations of Early Intervention Centres through District Differently Abled Welfare Officers.
