From the State Commissioner for the Differently Abled letter Roc No.781/ST1/2014, dated 05.03.2015 and 17.08.2015.

ORDER:

In the letters read above State Commissioner for the Differently Abled has recommended that the proposal of Thanjavur District Collector and to stated that the National ID Card for the Differently Abled Person's have been provided to 35,591 persons in Thanjavur District so far. Out of which, 2210 persons are identified as the persons affected with Muscular Dystrophy and Autism. Already there is an Early Intervention Centre for Mentally Retarded children in the age group of 0-6 year is functioning in Thanjavur District. In which, 68 number of persons affected with Muscular Dystrophy and 59 number of persons with Autism are also getting their training. Apart from that as similar, an Early Intervention Centre for the Deaf is also functioning in Tarasuram, Kumbakonam. Further, he has stated that if an Early Intervention Centre for Children with Autism may be established along with the Early Intervention Centre for Mentally Retarded and Early Intervention Centre for the Deaf, which are already functioning would help to train the Differently Abled Persons in the District. Further, the District Collector, Thanjavur has requested to establish, an Early Intervention Centre for Children affected with Cerebral Palsy and Early Intervention Centre for Children with Autism with Government's funds and also requested permission to run the above centre through a Non Governmental Organisation (viz) "Siragugal" Special School for the Differently Abled Person, Thanjavur.

2. Hence, the State Commissioner for the Differently Abled has also recommended that the proposal of the Thanjavur District Collector and requested the Government to establish an Early Intervention Centre for Autism in Thanjavur District also during the year 2014-15 and sanction a sum of Rs.2,82,000/-.

3. The Government have examined the proposal of the State Commissioner for the Differently Abled and issue the following orders:-

- i. The State Commissioner for the Differently Abled is permitted to continue to run the Early Intervention Centre for children with Autism at Siragugal Special School, Thanjavur District.

- ii. Sanction is accorded for incurring an expenditure of Rs.2,82,000/- (Rupees Two lakhs and eighty two thousand only) as detailed below :-

- iii. To permit the State Commissioner for the Differently Abled to draw and disburse the amount with effect from the date of the sanction or date of functioning of centre whichever is later, subject to the availability of adequate infrastructure in the centre.
- iv. To permit the State Commissioner for the Differently Abled to decide on the selection and removal of implementing the Non Governmental Organisation with the concurrence of Government.
- v. Further State Commissioner for the Differently Abled has requested necessary proposal may be formulated to so as to avail Government of India assistance under SIPDA .

4. The expenditure sanctioned in para 3 (ii) above, shall be debited under the following head of account:-
