INTRODUCTION & BACKGROUND
TO THE
REQUEST FOR EXPRESSION OF INTEREST

1. ALIMCO set up in 1972 by Government of India for manufacture and distribution of aids & appliances for persons with disabilities has emerged as one of the largest manufacturers of Artificial Limbs and Rehab Aids in South Asia & Africa today. Headquartered in Kanpur, it is working under the aegis of the ministry of Social Justice & Empowerment, Govt. of India.

ALIMCO produces 35 a wide range of products with about 355 variants catering to needs and rehabilitation :

- Orthopedically Impaired Persons
- Hearing Impaired Persons
- Visually Impaired Persons
- Mental Impaired Persons
- & Aids for Daily Living for Elderly / Geriatric patents
- & Fitment of Tools and Equipment

2. ALIMCO is major implementing agency for the ADIP Scheme of MoSJ&E (Assistance to Disabled Persons - for more details may please refer link [www.](#)) & ADIP-SSA (ADIP under Sarva Shiksha Abiyan) being run by MoHRD and MoSJ&E to cater specially to School going children between the age of 0 to 14 years. ALIMCO is distributing Aids & Appliances to PwD under these two Scheme across the country through organizing first Assessment Camp followed by Distribution Camp in any of the State across nation at Block / Village / District Level.

3. ALIMCO besides above is also providing Aids & Appliances directly to PwDs through its Prosthetic & Orthotic Centre located at Kanpur, Jabalpur, Bhubaneswar, Bangalore, Chanalon(Punjab), New Delhi, Kolkata, Mumbai, Hyderabad & Guwahati suitable provision for entry of beneficiary details and printing of ADIP & ADIP-SSA is required to be made.

4. ALIMCO is Also Serving & providing Aids & Appliances to PwD under Corporate Social Responsibility (CSR) conducted on and behalf of other CPSE, SPSEs, Corporate Sector and through MPLAD funds allocated by Hon'ble Member of Parliament for the purpose similar provision for entry and uploading of beneficiaries details is required to be made in proposed automation.

- The company has so far provided Aids & Appliance to more than 4.0 million beneficiaries, covering geographical area of 3.28 million Sq. Kms. Encompassing 600 districts & 5500 blocks within 35 States/Union territories, in India @ of approximately 1.5 Lacs beneficiaries per annum.

- Main manufacturing unit is in Kanpur, Uttar Pradesh and other Auxiliary Production Centre (APCs) and Regional Marketing Centers (RMCs) are located / spread across 8 cities as cited above.
- Works in the servicing space and conducts camps in association with various State Governments, District Authorities for Fitment and Distribution of Aids and Appliances.
- ALIMCO has registered impressive growth in its top line and bottom line over the past few years with FY 2013-14 sales of INR Rs.165.02 Crores (Y-o-Y growth 26.72% from Rs.130.22 Crores to 165.02 Crores)) with a CAGR of 21.23% over five years.

5. BROAD DETAILS / BACKGROUND OF WORK ARE GIVEN AS UNDER :-

i) Study, Design , Development, Implementation & Management of Application Database to facilitates On-site / On-line beneficiaries details entry & duly filled in ADIP & ADIP-SSA form printing system.

ii) The above system is required to be Developed using Cloud / Web based environment to capture beneficiaries details at the place of Camp plan to be held any where in India at District / Block / Village level by the agency in consultation with ALIMCO representative present at the CAMP site.

iii) The beneficiaries details along with relevant document (including photograph of the beneficiaries) are required to be captured at the Assessment Camp Site (On-Site) and duly filled in ADIP & ADIP-SSA form indicating all the details are required to be printed at CAMP SITE to facilitate processing & signature of respective agencies / representative present in the CAMP.

iv) Based on assessment done in the Assessment Camp complete Details of Aids & Appliances required to be distributed in the Camp shall be worked out and available on line for the reference and planning by respective AAPCs / HQ, Kanpur.

v) The distribution of Aids & Appliances as assessed in the Assessment CAMP shall be made in the Distribution CAMP to be held at a subsequent date necessary entry of relevant details at the time of holding distribution camp is also required to be made by the agency.

vi) As soon as the distribution camp is over , all the beneficiary details are required to be uploaded onto our website www.alimco.in for public viewing for selected information and linking of respective ADIP & ADIP-SSA form & allowing viewing to authorized users.

vii) The various MIS report together with a comprehensive DASHBOARD for top management / authorized users are also required to be provided so as to make the system more transparent and efficient and more informative .

- II.  - The Application Database should provide exhaustive set of MIS reports and Digital DASHBOARD to monitor & serve PwD of the country in a more efficient and effective manner.
