Documentary Films - With a duration of less than 60 minutes and more than 20 minutes.

Short Films - With a duration of more than 5 minutes and less than 20 minutes.

Submission Deadline - 25 September 2015

6. Rules & Regulations

- (i) Open to all interested applicants.
- (ii) The film must be duly subtitled in English.
- (iii) The film must be produced in the last 5 years preceding the Festival.
- (iv) The film must be sent not later than 25 September 2015.
- (v) All screeners must be submitted ONLINE or in DVD/ BLU-RAY format or in USB Drive only. The applicant must ensure that the Online links do not have an expiry date, as the viewing process is done over a period of over 40 days.

- (vi) Final screening material must comply with festival technical standards.
