ORDER:

In Government Order first read above, orders were issued to delegate powers to the Principal Secretary / State Commissioner for the Differently Abled to incur expenditure and to implement the following 4 Welfare Schemes of Differently Abled Persons with the condition that the expenditure should be incurred only within the Budget provision of the respective Head of Account:-

- i. Maintenance Allowance to Mentally Retarded persons.
- ii. Maintenance Allowance to Severely Affected persons.
- iii. Maintenance Allowance to Persons affected with Muscular Dystrophy, and
- iv. Maintenance Allowance to Leprosy affected persons.

Further, the Government have permitted the Principal Secretary / State Commissioner for the Differently Abled to send necessary proposal to Government for sanction of funds if required for the additional beneficiaries identified subsequently in the month of September and February.

2. In Government Order second read above, orders were issued to sanction an additional fund of Rs.1,14,48,000/- to provide maintenance allowance to the wait listed mentally retarded and severely affected persons and permitted the State Commissioner for the Differently Abled to disburse the maintenance allowances for four months with effect from December 2013 to March 2014 and to incur this amount, pending provision of funds in the FMA 2013-14.

3. Consequent to the above Government Order, in the letters third read above, among the other things the State Commissioner for the Differently Abled has stated that

there are 274 number of additional beneficiaries identified in the category of severely affected persons during February 2014 and requested to sanction a sum of Rs.5,48,000/- (274 Nos. x Rs.1000/- x 2 months) to provide maintenance allowance to them at the rate of Rs.1000/- per month for two months (viz) February and March 2014 for the financial year 2013-14.

4. The Government, after careful examination of the proposal of the State Commissioner for the Differently Abled accord sanction for a sum of Rs.5,48,000/- (Rupees Five lakh and forty eight thousands only) (274 Nos. x Rs.1000/- x 2 months) to provide maintenance allowance for two months (viz) February and March 2014 for the year 2013-14 to 274 No. of additional beneficiaries identified in the category of severely affected persons during the month of February 2014 at the rate of Rs.1000/- per month.

5. The expenditure sanctioned at para 4 above shall be debited under the following Head of Account:-

“2235- Social Security and Welfare-02. Social Welfare-101- Welfare of Differently Abled Persons- I- Non Plan- CD- Maintenance Allowance to the Severely affected Differently Abled Persons-09- Grants-in-aid 03 Grants for Specific Schemes.

6.. Necessary provision of additional funds of Rs.5,48,000/- (Rupees Five lakh and forty eight thousand only) over and above the budget provision will be provided in RE/FMA 2014-15. Pending provision of such funds in RE/FMA 2014-15, the State Commissioner for the Differently Abled is authorized to draw and incur the expenditure sanctioned in para 4 above. The State Commissioner for the Differently Abled is also requested to include this expenditure of Rs.5,48,000/- (Rupees Five lakh and forty eight thousand only) in the FMA for 2014-15, while sending a proposal to Government in Finance(SW) Department without fail.
