## **ORDER:**

In the Government Order first read above, Government have issued continuance orders for the scheme of Early Intervention centres for children with Hearing Impairment in 32 districts and for conducting Orientation Training Programme for Special Educators for the year 2013-14 and sanctioned a sum of Rs.89,67,900/- .

2. In the letters 2<sup>nd</sup> read above the State Commissioner for the Differently Abled has sent a proposal to Government for continuance of the Scheme of Early Intervention Centres for infants and young differently abled children with hearing impairment in 32 districts for the year 2014-2015 and requested to sanction an amount of Rs.89,89,500/- for the scheme.

3. The Government, after careful examination, has decided to accept the proposal of the State Commissioner for the Differently Abled Persons and issue the following orders:-

- i. Permission is accorded to the State Commissioner for the Differently Abled to continue and implement the scheme of "Early Intervention Centres for infants and young differently abled children with hearing impairment through Non Governmental Organisations in 32 Districts and for conducting Orientation Training Programme for Special Educators for the year 2014-15, and also, sanction is accorded for a sum of Rs.89,67,900/- (Rupees Eighty nine lakhs sixty seven thousand and nine hundred only) as detailed in the Annexure-A & Annexure-B to this order.

- ii. Permission is accorded to draw and disburse the amount as an advance to the Early Intervention Centres of the Non Governmental Organisations through the District Differently Abled Welfare Officers.
- iii. Permission is accorded to depute 6 Special Educators for the Diploma in Teaching Young Hearing impaired as in service Training Programme at Bala Vidyalaya Institute for the Teacher Training, Chennai during 2014-15 and sanction an amount of Rs.32,400/- (Rupees Thirty two thousand and four hundred only) for this purpose as detailed in Annexure-A to this order.
- iv. Permission is also accorded to conduct Orientation Training Programme to the Special Educators through Bala Vidyalaya Institute for Teacher Training , Chennai and for this purpose sanction is accorded for an amount of Rs.1,67,500/- (Rupees One lakh sixty seven thousand and five hundred only) as detailed in Annexure-B to this order. The sanction of total cost for the continuance of 32 Early Intervention Centres, DTYHI (in service Training) and orientation training programme is Rs.89,67,900/- (Rupees Eighty nine lakhs sixty seven thousand and nine hundred only)
- v. Permission is accorded to decide on the removal and selection of implementing Non Governmental Organisations, after observing due formalities and principles of natural justice in consultation with Government.

4. The expenditure sanctioned at para 3(i), 3(iii) and 3(iv) above shall be debited under the following Head of Account:-
