Conference Programme:
A Snapshot

Partnering with corporate for CSR

CSR is the buzz word for NGOs. This course will discuss how to transform it into an achievable collaboration between corporate and NGOs.

Current prevalence studies in India

The course will provide updates & details on the current blindness survey being conducted in India.

Indicators for Quality

The course presents tools and evidence for improving eye care service delivery. It aims to equip and better understand system related protocols.

Eye Health Linkages

This course will consider linkages of eye care programmes with poverty alleviation programmes bearing an impact on eye health.

Environment & Eye Health

The course deals with UV rays impact on eye health, based on a study by RP Centre.

Courses on Eye Care Delivery to the Unreached

Cataract backlog free India: way to achieve it

India has made giant strides in achieving high volume cataract surgery. Yet, elimination of blindness due to cataract, district by district, appears to be a long road. The course will discuss strategies and interventions to realise a cataract backlog free India.

Bridging Inequity Paediatric in Eye Health

A focus on paediatric eye health is linked to a healthy economy. The course looks at the existing gaps and possible ways to address them.

Primary Eye Care Approach through Vision Centres

Vision centres are one of the main bridges to reach community at primary level. This course will discuss challenges and updates of this approach.

Innovations in Eye Care

Innovations in community eye care are key to advance eye care. This course will look at innovations in and beyond equipments to explore where technology meets eye care.

Innovative community outreach approaches

Authors of some leading research papers in community outreach will discuss their papers.

Community approaches to Emerging Eye Diseases

The course will focus on diabetic retinopathy and glaucoma screening and management and approaches at community level.

Courses on Improving Patient Outcomes in Cataract Surgery

Patient safety in cataract surgery is important due to high volume of surgery, extremely high patient expectations, and the increasing trend towards surgery for milder lens opacities and cannot be compromised. The courses aim to discuss issues of generating patient demand for services, improving surgeon training, efficiency, patient satisfaction with better results, minimising infection and error, innovations in eye care delivery and measuring outcomes.

Skill Enhancement for Optometrists and Ophthalmic Assistants

The availability of skilled ophthalmic paramedics determines the quality care, efficiency in delivery of eye care and access to patients. This track gives an opportunity to allied ophthalmic personnel to improve their skills and upgrade their knowledge. This course will provide an opportunity to allied ophthalmic personnel to improve their skills and upgrade their knowledge and will be a balanced mix of practical sessions and theory and will include 5 parallel sessions.

Free Papers and Posters

The topics for Free Papers and Posters will pertain to aspects in Organisational Development, Eye Care Delivery to the Unreached and Optometry.
