**Name of the Course: ADVANCED CERTIFICATE COURSE IN INCLUSIVE EDUCATION (Cross Disability)**

1	Nomenclature of the Course	Advanced Certificate Course in Inclusive Education (Cross Disability)
2	Mode of the Course	Part time ( <i>On Pilot Basis for two batches</i> )
3	Duration	06(six) months
4	Eligible institutions/universities	RCI approved institutions conducting special education courses for the last four years at D.Ed.Spl.Ed. / B.Ed.Spl.Ed.
5	Intake	30 (Maximum) and minimum 10 (for the year 2017-18)
6	Eligibility for admission	Candidates with Diploma/Bachelor in Education Special Education, any specialization
7	Admission Procedure	Admission shall be given on merit basis on the %age of marks obtained in eligibility qualification i.e., D.Ed.Spl.Ed. / B.Ed.Spl.Ed. A copy of merit list to be sent to RCI and also to be displayed on the notice board of the institution. Relaxation and reservation shall be applicable as per norms of the respective State Govt. /UT and G.o.I. guidelines for Central Govt. Institutions
8	Course Fee	Rs. 5000 (course fee) + Rs. 2000(examination fee)= Rs. 7000 per candidate. No other fee shall be admissible. For monitoring, evaluation and development of study materials, RCI shall charge 10% of the course fee per student.
9	Benefits/Advantage	100 CRE Points to be given on successful completion of the course for renewal of RCI registration.
10	Exemptions, if any	For RCI approved institutions, NOC from the State/UT for this course is not required.
11	Application format	Prospective institutions may apply offline alongwith required fee on prescribed application format available on the Council's website.
12	Application & Processing Fee	Rs.5000/- to be paid through RTGS to the Council in the designated account
13	Date of availability of forms	05 May,2017
14	Last date for submission of proposal	31 May,2017
15	Date of Commencement of Course	July, 2017
